Advertising rates do not include design and artwork, which remain the responsibility of the advertiser.

## Web Site

The Law Society's web site consists of a member's only area and a publicly accessible home page.

Advertisement and notices can be placed on the Bulletin Board in the member's area which is a very effective way to reach Tasmanian practitioners.

Notices remain on the Bulletin Board for a month (after which they are archived but remain searchable). Advertisements can be posted to the Bulletin Board for \$90 per month – this is a free service for current Law Society Members.

## Paper Copy Mail out to Practitioners

The Society can mail out notices to all practitioners and associate members at a cost of \$500 plus materials. Printing/copying, paper and freight to the Society remain the responsibility of the advertiser.
