ABOUT THE LEGAL PROFESSION BOARD OF TASMANIA

The Legal Profession Board of Tasmania is the sole body responsible for receiving and investigating complaints about the conduct of lawyers. The Board is an independent statutory body and consists of six Board Members appointed by the Governor of Tasmania.

What does the Board do?


From the public perspective the major role of the Board is the resolution of complaints involving lawyers. To this end, the Board receives and investigates complaints about the conduct of lawyers and determines how they should be dealt with. Options available to the Board include suggesting practical options which will often resolve the issue without the need for a formal complaint; mediation; and a hearing which could involve discipline of the lawyer or referral of the matter to the Disciplinary Tribunal or the Supreme Court.

Another important function of the Board is advising lawyers upon appropriate standards of professional conduct. The Board also monitors emerging issues and trends in the legal profession and conducts education programs for the community about client-lawyer relationships.

The *Legal Profession Act 2007* ('the Act') received Royal Assent on 15 August 2007 and commenced on 31 December 2008.

A small administrative and investigative team, as represented in the organisational chart above, supports the Legal Profession Board.

The Board also retains the services of external Counsel when prosecuting practitioners in either the Disciplinary Tribunal or Supreme Court.



FUNDING OF THE BOARD

Pursuant to section 359 of the Act, the Board is to submit to the Minister an application for funding by 30 April in each year. The Minister approves an amount to be paid from the Solicitors' Guarantee Fund and directs the Solicitors' Trust to pay the approved amount from the Fund to the Board.

THE FUNCTIONS OF THE BOARD

The Board, through its statutory functions, aims to assist the legal profession in Tasmania to meet the highest standards of propriety and efficiency and to give effective redress to members of the public adversely affected by any shortfall in meeting those standards.

The functions of the Board as prescribed in the Act are as follows:

591. Functions of Board

The Board has the following functions:

- (a) to maintain the Register;*
- (b) to monitor the standard and provision of legal professional services;*
- (c) to receive, investigate and determine complaints made under Chapter 4 and, as necessary, refer complaints to the Tribunal or Supreme Court for hearing and determination;*
- (d) to approve terms and conditions of professional indemnity insurance policies provided to law practices;*
- (e) to advise the profession on appropriate standards of conduct;*
- (f) to monitor and identify trends and issues that emerge within the legal profession;*
- (g) to approve courses of continuing legal education;*
- (h) to advise the Minister on any matters relating to this Act;*
- (i) such other functions as may be imposed by this or any other Act;*
- (j) to conduct education programs relating to client-lawyer relationships for members of the public;*
- (k) such other functions as may be prescribed.*

MEMBERSHIP OF THE BOARD

The membership of the Board as prescribed in the Act is as follows:

590. Membership of Board

- (1) *The Board consists of –*
 - (a) *two persons who are local legal practitioners and who are nominated by the Law Society; and*
 - (b) *one person who is a local legal practitioner and who is nominated jointly by the Tasmanian Independent Bar and the Tasmanian Bar Association; and*
 - (c) *one person who is a local legal practitioner and who is nominated by the Minister; and*
 - (d) *two persons, nominated by the Minister, who –*
 - (i) *are lay persons; and*
 - (ii) *have not completed the degree of Bachelor of Laws or equivalent, either in this State or in another jurisdiction, whether or not combined with any other degree.*
- (2) *The members are appointed by the Governor.*
- (3) *The Board is to elect one of its members referred to in subsection (1) to be chairperson of the Board and that person holds office as chairperson for such term and on such conditions as are determined by the Board.*
- (4) *Schedule 2 has effect with respect to membership of the Board.*
- (5) *Schedule 3 has effect with respect to meetings of the Board.*

CURRENT BOARD MEMBERS

Chairperson of the Board:

Mr Keyran Pitt QC

Formally Mr Pitt QC has held appointments as Chairman of the Resource Management and Planning Appeal Tribunal; the Planning Appeals Board; the Mental Health Review Tribunal; and the Medical Complaints Tribunal.

He was also the Deputy Chairman for the Building Appeals Board and Environmental Protection Appeal Board, and, is an Honorary Fellow of the Royal Planning Institute of Australia.

Mr Pitt QC is the former President of the Bar Association of Tasmania and Medico-Legal Society of Tasmania. He actively supported the legal profession in Tasmania as a former Council Member of the Law Society of Tasmania and Bar Association of Tasmania.

Mr Pitt QC currently works as a Barrister and an Arbitrator and is also the Chairman of the Forest Practices Tribunal and Property Agents Board.

Mr Pitt QC is a nominee of the Minister.

Ms Paxton was the Tasmanian Legal Ombudsman from 1994 until 2008, the State Director of the Commonwealth Merit Protection and Review Agency and the Chairperson of a number of tribunals responsible for determining disputes and grievances.

Mr Peter Dane

Mr Dane has worked across the telecommunications and energy sector in excess of 22 years including as a Business Analyst at Hydro Tasmania in 1995 and management positions at White Pages, TasTel and Aurora Energy. Apart from his time at TasTel, Mr Dane has been responsible for Marketing, Pricing and Retail Regulation in the energy sector in Tasmania.

Mr Dane has served on a number of Boards and Associations, is a foundation member of the Australian Direct Marketing Associate and a graduate member of the Australian Institute of Company Directors. Mr Dane has a key focus on community involvement currently working part time as a coordinator for people moving into Independent Living Units in Aged Care and volunteering for organisations such as Royal Guide Dogs Tasmania, Community Transport and the Lenah Valley RSL.

Mr Anthony Mihal

Mr Mihal is a director of a generalist law practice in Ulverstone and he undertakes mainly litigious work including civil, criminal and child protection. He served on the Council of the Law Society of Tasmania for 7 years including as President in 2013-2014, the Law Foundation of Tasmania, the Management Committee of the North West Community Legal Centre including as Chair of the Law Council of Australia's Regional, Remote, Rural Lawyers' Advisory Committee.

Mr Mihal is currently a member of the Local Government Code of Conduct Panel, which investigates and hears code of conduct complaints against councillors and the Chairman of a charitable organisation called the Roland View Estate Trust.

Mr David Lewis

Mr Lewis, a prominent barrister on the North West Coast of Tasmania with in excess of 25 years' experience, was appointed to the Board on 27 June 2016. He has served on a number of Professional Boards and Committees over the years including his time as a member of the Bar Council of Tasmania.

Mr Lewis has enjoyed a diverse practice in law which, in addition to his experience at the Queensland and Tasmanian Bars, includes appointment as a senior Crown Prosecutor in Darwin, Managing Practitioner of the Katherine Regional Aboriginal Legal Aid Service and Legislative Counsel for the external Australian Territory of Norfolk Island.

DESIRABLE COMPETENCIES; SKILLS; AND ATTRIBUTES FOR BOARD MEMBERS

1. A sound understanding of, and or experience in, regulation within a professional context;
2. An ability to make a contribution in relation to the establishment and maintenance of professional standards;
3. The ability to reach firm conclusions and to exercise sound judgment;
4. A demonstrated capacity to act in an impartial manner;
5. A sound understanding of basic administrative review concepts such natural justice / procedural fairness;
6. An ability to understand and interpret legislation;
7. Demonstrated personal integrity and accountability; and
8. A desire and ability to work within a board / committee setting.

MEETINGS OF THE BOARD

Schedule 3 of the Act details the provisions in relation to meetings of the Board.

Frequency of meetings

The Board meets on average monthly however on occasion will conduct extra-ordinary meetings if required. The monthly meetings vary in duration however normally last for up to four (4) hours.

In addition to the monthly and extra-ordinary meetings, the Board conducts hearings. Hearings vary in time however it is not unusual for a complete day to be set aside for a hearing.

Preparation for meetings and hearings

Members receive meeting and hearing papers approximately eight (8) to ten (10) days prior to the meeting or hearing.

Preparation time for a meeting or hearing will vary, however on average at least between two (2) to five (5) hours preparation time is expected.

Decision Writing

Board Members are also required to, on occasion, draft, settle and review written decisions and reasons in respect to matters before the Board which have been brought to finality.

REMUNERATION OF BOARD MEMBERS

The Minister for Justice determines the sessional fee paid for the Chairperson of the Board and for Members in accordance with Schedule 2 Clause 5 of the Act.

The current sessional fee is set at \$416.00 for the Chairperson and \$315.00 for Members.

An additional sessional fee is payable in circumstances where Members have engaged in Board activities which have exceeded two (2) hours. No Member is entitled to more than two (2) sessional fees in respect of attendance at meeting on any one day.
